480-8-5-.06 Deputy Inspector Personal Protective Equipment

Due to the hazardous conditions experienced during the conveyance inspection process, the ADOW Inspection Department shall supply all personal protective equipment (PPE) for Deputy Inspectors employed by ADOW. This shall include uniforms, outerwear (jackets), boots (\$200 allowance), safety vests, hardhats, gloves and any other essential equipment deemed necessary by the Administrator or his/her designee.
